

## **Standing Rules of Kent State University Panhellenic Association**

### **Section 1. Programming Policy**

- A. Dates for Panhellenic and chapter programming will be established at a meeting of chapter representatives on a date set by the Vice President of Communications and Vice President of Programming and Engagement for the following year.
- B. Programming date priority will be determined in order of Panhellenic programming points. A list of events worth programming points will be distributed by the first Panhellenic Council meeting of each semester. Programming points will be calculated based on percent attendance of the roster on file with the Fraternity and Sorority Life office at qualifying events, and will be distributed by the Vice President of Communications and an update will be provided at each regular meeting of the Panhellenic Council.
- C. The Kent State University Panhellenic Association considers a week to begin on Monday and end on Sunday.
- D. Programming limitations
  - i. No more than three active philanthropy events held by women's only sororities will be held in the same week.
    - i. No sorority may hold two active events in the same week.
    - ii. No more than two events may be the chapter's main philanthropy event.
    - iii. Definition of active philanthropy events are ones that require attendees to actively participate in the event. Examples may include, but are not limited to, performances, sporting events, educational events, bingo, etc.
  - ii. No more than three passive philanthropy events or fundraisers held by women's only sororities will be held in the same week.
    - i. No sorority may hold two passive events in the same week.
    - ii. Definition of passive philanthropy events are ones that do not require active attendee participation. Examples include, but are not limited to, dine-to-donates, fundraisers, etc.
  - iii. No more than two social events held by women's only sororities will be held on the same day.
  - iv. No chapter will be permitted to host an event on the same day as a Panhellenic sponsored event.
    - i. Events that conflict in day, but not time, may be submitted to the Vice President of Programming and Engagement for consideration.
  - v. Should a sorority choose to dually partner with another organization for an event, such as a philanthropic or social event, it must be approved by the Vice President of Programming and Engagement and the Vice President of Communications no later than two weeks before the event shall take place to ensure that it adheres to all rules listed above. Should a non-member organization host an event that benefits a sorority, the event does not need prior approval and is not subject to these rules.
- E. All changes to chapter events must be made no later than two weeks before the event shall take place. These changes must be submitted to the Vice President of Programming and Engagement for approval.

### **Section 2. Regular Meetings**

Regular Meetings of the Panhellenic Council shall be held on Tuesday at 8:00 pm. The Regular Meeting schedule shall be as follows per week: Executive Board Meeting, Executive Board and Delegate Meeting, Executive Board Meeting, General Body Meeting.



### **Section 3. Budget Approval**

The budget of the Kent State Panhellenic Council shall be approved by a two-thirds majority vote of the Panhellenic delegates in the first General Body Meeting of that academic term.
